**Council Action**

Councilmember Mitchell moved to approve the Minutes as presented. Councilmember Hartley seconded the motion. A vote was taken and passed, 7-0.

**5. PUBLIC HEARING, ZONING FILE 14-13 AND CONSIDER ADOPTION OF ORDINANCE NO. 4051, AMENDING THE COMPREHENSIVE ZONING ORDINANCE AND ZONING MAP TO GRANT A CHANGE IN ZONING FOR A 79.11-ACRE TRACT OF LAND FROM LR-M(2) LOCAL RETAIL, PD PLANNED DEVELOPMENT, AND TO-M TECHNICAL OFFICE TO PD PLANNED DEVELOPMENT FOR THE PALISADES PLANNED DEVELOPMENT CODE FOR PROPERTY LOCATED ON THE WEST SIDE OF CENTRAL EXPRESSWAY, GENERALLY BOUNDED BY COLLINS BOULEVARD TO THE WEST, PALISADES BOULEVARD AND GALATYN PARKWAY WEST EXTENSION TO THE SOUTH, AND PALISADES CREEK DRIVE TO THE NORTH.**

**Public Hearing**

Mayor Maczka opened the Public Hearing at 8:50 p.m. The applicant, Larry Good, deferred his comments until after the Public Hearing. A list of Public Hearing participants with their position noted is attached to the Minutes as *Exhibit A*.

Applicants Larry Good and Mark Jordan addressed Council and answered questions. At the request of Mayor Maczka, Mr. Jordan agreed to reduce the multi-family to a maximum of 1090 units of which 140 must be Type 1 construction and a 2 year phasing plan in which he will not break ground on the additional 350 units until June 2016.

With no further comments, Councilmember Mitchell moved to close the Public Hearing at 10:32 p.m. seconded by Councilmember Hartley and approved unanimously.

**Council Action**

Mayor Pro Tem Townsend moved to approve the request and Ordinance No. 4051 with the Special Conditions from the City Plan Commission and the maximum number of multi-family capped at 1090 with a two year phasing for the last 350 units in which a building permit will not be issued and ground will not be broken until June 2016. Councilmember Solomon seconded the motion. A vote was taken and passed, 5-2 with Councilmembers Hartley and Mitchell in opposition.
